# AMENDMENT to the Deed of Dedication, Declaration, and Restrictive Covenants of The Preserve at Grand Lake o' the Cherokees, a Subdivision in Delaware County, Oklahoma.

WHEREAS, the Deed of Dedication, Declaration, and Restrictive Covenants of The Preserve at Grand Lake o' the Cherokees was recorded with the Delaware County, Oklahoma Clerk on February 20, 2008, at Book 1806, Pages 662-692 (the "Deed of Dedication").

WHEREAS, identity of the Owners of the Lots within The Preserve subdivision was established by means of a Special Certificate issued by Grand River Abstract & Title Company, a duly qualified and bonded abstractor. Such Special Certificate is attached hereto as Exhibit A.

WHEREAS, notice of a Meeting of the Owners held on SEPTEMER 15, 2018, was provided to all Owners identified on Exhibit A in accordance with the Deed of Dedication.

WHEREAS, at the <u>Secretors</u>, meeting, a Majority of the Owners voting in person or by written proxy voted to Amended the Deed of Dedication, amending the "Individual Assessments" provision of the Deed of Dedication. The results of such vote shall remain on file with the Association as the official act of the Owners.

### **NOW THEREFORE**

Article VI, Section 7 of the Deed of Dedication, shall be amended to read in its entirety as follows:

"7. Individual Assessments. An Individual Assessment may be levied by the Board against an individual Lot and/or Boat Slip and its Owner (1) to reimburse the Association for costs incurred in bringing that Owner and his/her Lot or Boat Slip into compliance with the provisions of this Declaration and By Laws; or (2) as provided by other provisions within this Declaration and By Laws."

All other provisions of the Deed of Dedication shall remain in full force and effect. Capitalized terms not defined herein shall have the meaning ascribed to such terms in the Deed of Dedication.
